

## Terms and Conditions

Terms and Conditions: By registering for and attending the Sitecore User Group Conference – Europe 2018 in Berlin, Germany on April 23<sup>rd</sup> – April 24<sup>th</sup>, 2018 (the “Event”), I hereby agree to the following:
